



## **PARTICIPANT RELEASE, DISCHARGE, WAIVER AND COVENANT NOT TO SUE**

### **THIS IS A LEGAL DOCUMENT. YOU MUST READ CAREFULLY.**

All Participants and parents must read, sign, and return this document to an authorized Minnesota Wild Hockey Club, L.P. ("Wild") or Saint Paul Arena Company, LLC ("SPAC") (Wild and SPAC collectively the "Company") staff member BEFORE access is gained to any area of the Saint Paul RiverCentre (the "Locale") associated with the **2026 Fraser Festival** (the "Event"). Subject to the sole discretion of Company, activities for the Event may include, but are not limited to, Raptor Center Meet and Greet, Zoomobile Program, Superhero Photo Booth, Rock Climbing Wall, Bounce House, Water Activity Center, Light Speed Game, Giveaway Activities, Silent Disco, Inflatable Tic Tac Toe, Mini Golf, Play Equipment, North Star Therapy Animals, Plinko Board, Sticky Soccer, Obstacle Courses, Let's Play Ball Activity, Sip Magic & Savor Smiles Activity, Cookie Decorating, Lemonade Stand, Balloon Twisting, 360 Video Booth, Spin the Wheel, Adopt a Pet with Plushies, Virtual Reality Experience, Wicked Community Interaction, Theatre Activity, Spin Art, Coloring Station, Shrek's Ogre Ears and Special Character Appearance, Face Painters, Tattoo Artists, Mirror Me Perfect Photography, Mini Floral Bouquet Station, Garden Finger Puppets, Children's Activities, Floral Fantasy Photo Op, Inflatable Slide, Arcade Basketball Game, Light Brite, and/or all additional events or activities.

**In consideration of \_\_\_\_\_ (the "Participant") having been provided the opportunity to participate in the above-Event and, in the case of a minor participant, his/her parent or guardian (collectively the Participants") hereby voluntarily agree as follows:**

**RELEASE FROM LIABILITY AND COVENANT NOT TO SUE.** Participants, for themselves and their personal representatives, heirs, next of kin and assigns, hereto release and discharge Company, the National Hockey League, each sponsor and promoter of the Event and each of their respective parents, subsidiaries, owners, partners, employees, representatives and other affiliates (collectively, the "Releasees") from, waive in respect of each and covenant not to sue any Releasee for any and all liabilities, losses, damages, costs, expenses (including, but not limited to, attorneys' fees and expenses), causes of action, suits and claims of any nature (collectively, the "Liabilities") arising from, based upon or relating to the personal injury, death, damage to or loss of property of the Participants sustained in connection with participation in the Event (hereinafter "Release"). Such Release, shall include, but not be limited to, any and all Liabilities caused in whole or in part by the negligence of any Releasee in connection with the Event.

**PARTICIPANTS ASSUME RISK.** Participants are aware of and understand the inherent risks, dangers and the potential for injury that exists, and agree to assume all risk of and responsibility for personal injury, illness/sickness or death to, or damage to or loss of property of the Participants arising from or relating to participation in the Event. Such assumption of risk includes, but is not limited to, any personal injury, illness/sickness or death, or damage to or loss of property, arising from, based upon or relating to the lack of skill or improper conduct of any participant, the acts or omissions of any coach or supervisor, and any personal injury, illness/sickness or death, or damage to or loss of property, caused in whole or in part by the negligence of any Releasee. Each of the Participants understand and agree that, in the event of any injury to the Participant or Participants, none of the Releasees will be responsible for any decisions relating to medical treatment or for such treatment itself. Each vendor will supply Participants with adequate equipment and safety measures prior to participating in each activity.

**RIGHT OF PUBLICITY/MARKETING.** Participation in the Event shall constitute permission to use the name, likeness or any other identification of Participant for advertising, publicity, or any other purposes in connection with the Event or the business of any of the Releasees, in any medium, at any time, without compensation or right of prior review or approval by the Participants. Participants agree, for themselves and their personal representatives, executors, heirs, next of kin and assigns, to release and discharge each Releasee from, to waive in respect of each Releasee, and not to sue any Releasee for, any and all Liabilities arising from, based upon or relating to any claim for invasion of privacy, violation of right of publicity, defamation or appropriation, or any similar claim, in connection with any such use. Participants understand and agree that any information provided by them in this document may be used by Company for marketing of future products and services.

**NO OBLIGATION OF RELEASEES.** None of the Releasees shall have, or be deemed to have, any obligation to the Participants hereunder or otherwise in connection with the Event, including, but not limited to, with respect to the continued provision of equipment and continuation of the Event at the Locale or otherwise.

**MISCELLANEOUS.** This Release shall be governed by and construed in accordance with the laws of the State of Minnesota, without reference to the conflict of law provisions thereof. If any portion of this Release be held invalid or unenforceable, the remaining portion hereof shall not be affected thereby and shall remain in full force and effect.

**REPRESENTATIONS.** Participants state that the Participant is in good physical condition, is physically fit to participate in the Event and is not subject to any medical condition that may pose any risk of harm or disability to others.
